# Information & Rules

## 2026 Springs Coin Show

1. Make checks payable to Colorado Springs Coin Club
2. MAIL CHECKS TO: CSCC PO BOX 60404 COLORADO SPRINGS, CO 80960
3. Table assignments will be considered on 1<sup>st</sup> come 1<sup>st</sup> serve basis. The committee has final decision on table assignments. Full payment is due with application. A confirmation email will be sent when payment is received and a table is assigned.
4. Dealers that do not have a Colorado Single Event License or Colorado Springs sales tax license may remit sales tax to the City of Colorado Springs. Coins & bullion are subject to a city tax of 3.12%, other items are subject to state, county, and city tax of 8.25%. These rates are subject to change.
5. Applicant releases the Colorado Springs Coin Club and Colorado Springs Numismatic Society, club officers, members and BPO Elks Lodge 309 from any liability for loss, theft, damage, or injury at event facility.
6. We will allow full refund cancellations if cancelled 10 days prior to show date. (If table can be resold).
7. All dealers must check in at the front desk when entering the building. All contracts must be signed and payments made before dealers will be allowed on sales floor.
8. Dealers can start packing up on Saturday at 3pm unless prior arrangements are made.
9. Club members will be available to assist with move-in and move-out.
10. 8' Tables will have 6' tables for inventory as space permits.
11. Every table will have 2 chairs for guests and 1 chair for dealers.
12. Alcoholic beverages and smoking are not permitted at the BPO Elks Lodge.
13. Food will be available for purchase from the Elks – breakfast & lunch both days.

**Directions:** Traveling South on I-25, Exit 146 Garden of the Gods Rd,

Go EAST on Garden of Gods Rd, Turn Right on Nevada Ave.

Travel approximately 1 mile, Elks Lodge on Right across from power plant. Free Parking available on West side of building.

Off load your vehicle at Elks entrance, wheeled carts are recommended, we will have 2 available for your usage. Please Park after unloading on the other side of the parking lot away the coin show entrance.
