#### **November Meeting**

Twenty-seven members with no guests were in attendance at our Sunday afternoon meeting.  
The secretary was not present; however his report as published in the November newsletter was given and accepted.  
The treasurer's report for November was given and accepted.

#### **November Business**

It was mentioned that there would not be a routine December 2014 meeting. Our December Christmas party would be at the Golden Corral Restaurant, 1970 Waynoka Road (east of Powers, north from Palmer Park Blvd), Tuesday evening, December 9 from 5:30 to 9:00 PM. and that prizes are planned for all in attendance!

There was discussion about active CSNS members being able to get a 50% discounted table at the annual CSNS/CSSC Coin Show. Active membership would be defined as having attended at least 6 monthly meetings in the prior 12 months. Professional dealers would be excluded from the discounted tables. A professional coin "dealer" would be defined as any dealer who exhibits/shows at more than one coin show a year. It was also mentioned that these "discounted" tables would likely be located toward the back (or grouped along a wall) of the show (not in the front or choice locations) so as not to irritate any dealers who have paid full price for their tables. The idea is to encourage more membership participation, allowing our Society/Coin Club members the opportunity to sell off some of their excess or no longer collected inventory. This proposal was voted upon with 24 in favor and 3 against.

This recommendation will be forwarded to the January Coin Club meeting and the annual CS Coin Show organizing committee.

### **World War I Commemorative**

"To honor their service and sacrifices, Congress created the World War I Centennial Commission in 2013 and tasked them with planning and executing activities to commemorate the centennial of World War I through the use of private donations and coin sales. By requiring the Secretary of the Treasury to mint coins to commemorate the centennial, this bill would allow us to honor the memory, service and sacrifice of the brave veterans of World War I, while providing the means to pay tribute to the end of World War I battlefield hostilities. Other great conflicts, including the Civil War, World War II, the Korean War, and the Vietnam War, have all been memorialized on United States commemorative coins, but no such honor has been extended to the brave veterans of World War I. The year, 2014, was the 100th anniversary of the start of World War I, making it very fitting that we pass this measure this year."
